

2025 Corporate Sponsorship Opportunities

NRMC inspires risk champions in mission-driven organizations and develops and delivers web applications, books, virtual and in-person training for nonprofits of all sizes and missions. NRMC's educational mission is supported by nonprofit and industry clients and by corporate support provided by our Platinum Sponsors, Corporate Sustainers, and Conference Sponsors. NRMC's Affiliate Members include 185 umbrella organizations whose members, nonprofit customers, and chapters represent a wingspan of 45,000 nonprofits.

- 3. **Sponsor of the 2024 Risk Summit (\$9,000/event)** NRMC's 2025 Risk Summit is a two-day, in-person scheduled for October 27-28 in Reston, VA. Event promotions will be sent throughout the year to our list of nonprofit and industry subscribers. An estimated 200 risk professionals attend the in-person conference, with most attendees representing large nonprofits and NGOs or large networks of nonprofits across the diverse mission spectrum. The cost to sponsor the conference is \$9,000. Sponsors are recognized and showcased in periodic issues of the *Risk eNews*, in dedicated conference promotions, and during the in-person event.
